Accommodations

Each booking includes a private European double room and bathroom, with a queen or king size bed. Please let me know if you prefer two single beds as soon as possible. Most hotels are able to accommodate a few such requests, but most likely not for the whole group.

Registration

An initial deposit of \$1000/participant is required to reserve a spot on the trip. Initial registration deadline: January 18, 2026.

Following receipt of the deposit, the remainder will be requested via invoice, and March 15, 2025.

PLEASE NOTE: Registration deposit and the remainder must be <u>received</u> by the deadlines listed:

Deposit fee (by January 18, 2026): \$1000 / person

Remainder (by March 1, 2026): \$3,335 individual (single occupancy)

\$2,725 / person (double occupancy)

In order for you to be fully accepted for participation, you will need to sign, date and submit the Liability & Release Form that will be emailed to you along with the outstanding balance invoice (directly following receipt of the deposit).

What If I Need To Cancel?

Non-refundable portion of registration fee: \$500/person

The remainder of the deposit (\$500) is refundable through January 18th*

Beyond this date, your deposit is non-refundable. If cancellation is unavoidable, we will try to help you find someone to take over your reservation if possible. In this case you would receive a refund, but it is not guaranteed that a replacement can be found. If final payment is not received by March 1st, your spot and deposit will be forfeited, and participation re-opened to booking.
